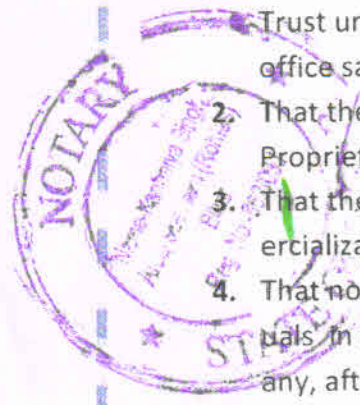

7. That the Principal and Manager of school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time.
